Thereafter, the following points were discussed and decisions were taken that the concerned officers.

S.No	Item	Action Taken By
1	Solid Waste Management Plan	As directed in the previous meeting held on 24 <sup>th</sup> July, 2021 the departments had to give the name of expert who will advise the committee for effective implementation of Solid Waste Management Plan. However, no such name was proposed by any departments after discussion it was directed that Chief Executive Officer, MC Samba shall contact an expert from Jammu/


		Central University for the purpose. All Executive Officers were again directed to conduct drive for segregation of waste/garbage collection and disposal of Bio-degradable and non- degradable separately. The same directions were passed to the District Panchayat Officer, Samba for collection/ segregation of solid waste from panchayats. All the Municipal bodies apprised the meeting that the house to house collection of garbage has been started and coverage 100%.The DPO Shall also initiate process for establishment of Plastic Waste management units at block level the site for which shall be identified by the concerned tehsildar.
2	Bio- Medical Waste	The Chief Medical Officer, Samba again apprised that Bio Medical Waste is being disposed off as per norms and he provided inventory of institutions/ their bedding capacity/ total waste generated and quality control by ANMOL for disposal and authorization of PCB. He was directed to implement the disposal off Bio- Medical in respect of pvt. Industries.
3	Construction Rubble Management	The Block Development Officers/ Executive Officers, Municipal Committee were directed to ensure that the Executive agencies lift the Construction/ dismantling debris for construction of roads. They were further directed to identify the trenches for using as landfills and restrict dumping of rubble near water bodies. District Medical Officer was directed to ensure that no Rubble waste/ RBM is transported without cover as per directions of Hon'ble NGT.
4	Industrial Pollution Control	The officer from Pollution Control Board briefed that almost every unit has its own ETP and CETP have been constructed by SIDCO. Estate Manger SIDCO and General Manager Industry shall carry

Since commitment has also been made by District Administration during the visit of Hon'ble Union Minister of micro small and medium industries under public outreach program to District Samba for Plantation of 10,000 Plants during the year. The Meeting was apprised a good number of plants have been planted by the unit holders during this monsoon season the DFO sectorial and DFO Social Forestry shall provide sapling of the plants to the unit.</p>
5	<p>Plantation Drive (Social Forestry)</p>	<p>The chair requested all departments to intensify the plantation under the convergence with MGNREGA. Chief Education Officer Samba was again directed to use all resources for generation of awareness among students towards the importance of forests and to conduct more IEC activities and activation of Eco clubs.</p> <ul style="list-style-type: none"> <li>All the concerned Departments Viz Forest, Social Forestry, Soil Conservation, Sericulture, Horticulture have launched plantation drives in the in the socially launched rainy season.</li> </ul>
6	<p>Updating the Portal</p>	<p>It was observed that many activities are going on in the district for betterment of Environment and District Informatics Officer, (NIC) was asked to ensure the uploading of all activities conducted under District Environment Plan on the Portal for in compliance to the directions of Hon'ble NGT.</p>
7	<p>Single Use Plastic</p>	<p>The Officers were directed to ensure the complete ban on use of Single Use Plastic in their offices and discourage burning of any kind of waste particularly Plastic Waste, being an unlawful activity.</p>

8	Uploading of District Environment Plan	It was decided that Divisional Officer, PCB Samba will be responsible for uploading the updated District Environment Plan on NGT Portal and also call all the Officers for updating the same on regular basis and District Officer Soil Conservation Samba shall ensure the updated plan to be uploaded on the website.
